Requirements for Hamper Applications and Eligibility 2010

1. Application must be completed **in full** and returned to FCSS with **the necessary documentation**: Paystubs, Tax Assessments etc. as required. **Please make sure that ADDRESSES, AND PHONE NUMBERS ARE CORRECT.**
NO APPLICATION WILL BE ACCEPTED WITHOUT ALL REQUIRED DOCUMENTATION.
2. Applications must be filled out and signed by the applicant – due to FOIP regulations we can't take referrals from other people.
3. Applicants must be a resident of Stettler, County of Stettler, Botha, Donalda, Byemoor, Gadsby or Erskine. Anyone outside these areas will be referred to the appropriate offices.
4. We **do not** provide gifts or hampers for visiting **grandchildren/children or other guests. They are for the permanent residents of that household only.**
5. **All employed** adults residing in the household must include a copy of either their 2009 Tax Assessment (Line 236) or previous month's paystubs.
This pertains to all adults in the household including Room-mates and/or Boarders.
6. Applicants **providing false information** or receiving a hamper from another society or organization will be **PERMANENTLY** taken off the Stettler Hamper Society list.
7. **CUT-OFF DATE for applications is DECEMBER 10, 2010.** We can't guarantee a hamper to any applications that are received after that date.
PHONING DATE: Dec 14 & 15/10 – You will be contacted by the phoning committee to verify your information on these dates – please ensure that you are home to receive this call.
8. **DELIVERY DATE: DECEMBER 22, 2010** – Please make sure you have someone at **home and up** to accept these between **8am and 11am** that morning.
If you are not going to be home due to work commitments etc. please make sure you notify FCSS before that time so we can make arrangements for pickup.
If we are unable to deliver your hamper or have alternate pickup arrangements in place your hamper will be sent back.
